This Award recognizes schools that offer a minimum of 2 CTE courses whose instructors belong to SDACTE/ACTE. These schools will appear in the April publication of **Techniques**, and they will also be recognized at the Awards Banquet Monday night at summer conference. Once again, your Board of Directors wants to recognize those schools that have 100% of their CTE staff belonging to their professional organization (SDACTE/ACTE). Our goal is to heighten the public awareness of CTE and the professionalism of our schools and educators.



In case you didn't know, this is a special time of year for many FACS departments around the state. In addition to CTE Month, February 10-14 is Family, Career and Community Leaders of America (FCCLA) week and Educators Rising week. The first group mentioned having a strong and impressive history here in South Dakota and the latter just beginning their journey as a new state-wide affiliate. 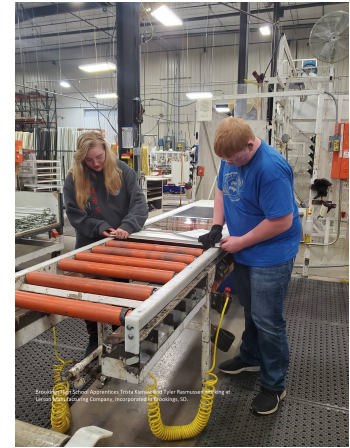

We are a unified state for membership so when you join SDAAE, you are a member of SDACTE, NAAE, ACTE. Other divisions work the same way. Here are some reasons to join.

Our organizations serve as our voice- without members we have no organizations and no voice.

12. Opportunity to attend regional & national conferences.

Innovative Program Selected

The SDACTE Board of Directors has selected Daniel Berg, Business/Technology Teacher and his apprenticeship program at Brookings High School as the Region V Innovative Program from South Dakota. Berg will be recognized in April at the Region V Leadership Conference at Lake Tahoe.



Brookings High School, in partnership with the Brookings Manufacturing Consortium (Daktronics, Falcon Plastics, Larson Manufacturing, and Counterpart, Inc.), developed the **first registered apprenticeship program in SD** specifically for 16 and 17 year olds. The Brookings Production Technologist Registered Apprenticeship launched in the fall of 2018 with ten juniors and seniors filling positions such as machine operation, machine programming, technical assembly, and engineering. Student interest is high. The program has only been marketed to students in Mr. Berg's Robotics class. In just two application cycles, over fifty applications have been submitted. As seniors graduate out of the program, more students continue to be hired. There are currently nine active apprentices registered with the U. S. Department of Labor. The apprenticeship program allows Brookings High School students the opportunity to **explore manufacturing careers** while earning a paycheck. Students complete an application, tour the businesses, and participate in real interviews with HR representatives from each company. Not only do high school students learn soft skills, they are given the chance to explore a career, all while earning high school credit, post-secondary credit, and apprenticeship credit. This model is similar to a new SD Department of Labor initiative. The Registered Apprenticeship Pathways Partnership's goal is to build high quality youth apprenticeship programs between secondary, post-secondary, and industry.

Dan Berg is an innovator who used a non-traditional educational model and partnered with both industry and postsecondary to maximize the benefit to students. When you step into Mr. Berg's classroom, it is as if you are walking on to the production floor of any of the manufacturing partners. Students who do not earn a position at one of the business partners can still **gain relevant experience from simulation**. Grant funds and support from the Manufacturing Consortium made the Robotics Shop possible. Small workstations around the room depict these manufacturing processes: 3D printing, CNC programming, and CAD.



During National Apprenticeship Week last November, the U.S. Department of Labor Office of Apprenticeship State Director along with SD Department of Labor representatives visited Brookings High School. Apprentices obtaining the milestone of 500 OJT hours were recognized. Also during the meeting, many of the apprentices commented that **participating in an apprenticeship has been a valuable experience** for them. They feel they have learned to use their time better and some even feel that their grades have improved.

This program contributes to the development of the next generation workforce. Students apply what is being learned in the classroom to their job duties under the direct guidance of an experienced mentor. Mentors help apprentices learn soft skills – like the importance of showing up to work on time, displaying the right attitude, and having respect for others. Mentors help apprentices **identify and achieve career goals**.



Lake Area Technical Institute submitted this application in recognition of Brookings High School and their efforts to develop the **next generation workforce**. The on-the-job training portion of the apprenticeship provides students the opportunity to explore different manufacturing careers with the business partners in addition to **learning beneficial soft skills**. Lake Area Tech instructors have noticed that students who participate in dual credits and/or work-based learning opportunities are **better prepared** for the courses and have the ability to **accelerate their learning**. If they choose to enter into their career after the apprenticeship, they have enough experience to no longer be considered an entry-level employee.

Scholarships Deadline Approaching

Please urge your students to apply for our SDACTE scholarships. This year we will be awarding two \$1000 scholarships to high school/and or post secondary applicants. The scholarship is available online and has been streamlined for easy application. In addition to the online application, your students will be asked to email an official transcript and one letter of recommendation from at CTE instructor. Deadline to apply is April 1.

The SDACTE Legislative Committee has emailed two legislative updates. The 2020 legislative session is a short session – just 35 days. The legislative calendar is available by clicking on this link <http://sdlegislature.gov/docs/legsession/2020/calendar.pdf>

While education-related bills have not garnered much media attention, there are several bills that relate to career and technical education. A brief description and link to each bill is available in the Legislative Update which you should have received from your division representative and/or president. Please review the information when you receive it. If you are not receiving the legislative update, please contact SDACTE Executive Director Dodie Bemis to insure SDACTE has your correct email address.

The legislative committee encourages SDACTE members to share program/student successes with their local legislators and media. Additionally, share this information with our national delegation. In early February ACTE sent a call to action asking members to contact senators to encourage them to co-sponsor the Senate CTE Month Resolution. The SDACTE Legislative committee reviewed the following bill introduced in the 2020 SD Legislative Session as of Friday, Feb. 7, 2020.

HB 1030 - Transferable general education classes between universities and technical schools

Clarification: This bill in and of itself does not provide funding for the full-time employee. The DOE separately, through the appropriations process, is requesting an FTE and the funding necessary for that position.

New Education Related Bills as of 2/7/2020:

HB 1145: An Act to authorize certain tribal members to attend certain institutions of higher education or postsecondary technical institutes without payment of tuition.

HB 1272 - An Act to revise the conditions for dual credit and to provide an appropriation.

This bill inserts the following language: If a student receives a failing grade in any course or withdraws from a course after the deadline and does not receive credit for the course, the student is responsible for the full dual credit rate of tuition for that course.

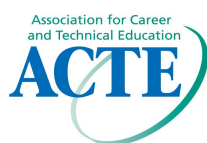
